29.11 Apologies for absence

Apologies were received from PCSO A Catterall.

30.11 Disclosure of Personal/Prejudicial Interests

Cllr Morris, as a neighbour, declared a personal interest in planning application 11/00105/FUL.

31.11 Minutes of the Meeting held 10 February 2011

Resolved: the Minutes (as circulated) be approved and signed by the Chairman as a correct record.

Resolved: Standing Orders be suspended to allow members of the public to speak.

32.11 Public Participation

Councillor Iddon advised he had been provided with incorrect information, regarding the Youth and Community Centre, which he had passed on at the February meeting and apologised for this. The views of Carrington Centre public meeting concerning the redevelopment have been passed on to Northern Trust. Further funding has been made available for pothole repairs. Councillors raised concerns regarding the response of Chorley Council to street names suggested for the Sagar House development by the Parish Council. Cllr Iddon will look into this.

Resolved: Standing orders be restored.

38.11 Diversion of Public Footpath 17

Councillors considered a notice of the diversion of part of Public Footpath No. 17, through Intake Farm, New Lane. The information was noted.

39.11 Lancashire Best Kept Village Competition

Councillors considered entries for the Certificate of Merit categories.

Resolved: St Mary's Church, the Health Centre, The Fields, Rigbye's, Sybaris, Verdi's, Parr Hall Farm, the Parish Council's noticeboard in the Carrington Centre, Ecclestone Cricket Club and the Village Green be entered into their respective categories.
