MINUTES of the Meeting held 13 October 2011 at 7.30 pm in The Changing Rooms, Drapers Avenue, Ecclestone.

131.11 Election of Chairman for the Meeting

In the absence of the Chairman and Vice Chairman Councillors elected a Chairman for this meeting.

Resolved: Cllr Monks be elected as Chairman for this meeting.

132.11 Apologies for absence

Apologies were received from Councillors L Armstrong, A Barnes, B Harrison, and W Mason, County and Borough Councillor K Iddon and PCSO A Catterall.

133.11 Disclosure of Personal/Prejudicial Interests

Cllr Harris, as an employee of the Primary Care Trust, declared a personal and prejudicial interest in an item forming part of agenda item 6 (Planning Matters).

134.11 Minutes of the Meeting held 8 September 2011

Resolved: the Minutes (as circulated) be approved and signed by the Chairman as a correct record.

135.11 Public Participation

A resident advised of concerns with proposals contained within the Sites for Chorley consultation document, which designates the area of land to the rear of the Carrington Centre, recently the subject of a refused planning application, as housing land.

Resolved: Agenda Item 10 be brought forward

136.11 Local Development Framework

Councillors considered a consultation from Chorley Council regarding the Sites for Chorley: Preferred Options Document.

Resolved: the following comments be submitted:

The land to the east of Tincklers Lane falls outside the natural development area of the village and the Parish Council would request its redesignation as open space, with an allocation for allotment/allotment gardens.

The Parish Council objects to the proposed designation of the land to the rear of the Carrington Centre as housing land and would request it retains its current safeguarded status. Any future development on this site should accord with local need.

The Parish Council questions the designation of Ecclestone as a Rural Local Service Centre.

11/00619/FUL Alterations to Eccleston Health Centre incorporating single storey front, side and rear extensions and a two storey front extension at Eccleston Health Centre, Doctors Lane.

11/00727/FUL Proposed manager's dwelling, hatchery building, stock ponds, access improvements, shelters and earth mounding and regularisation of existing car park and storage compound at Land 200m West of Bradley Hall Farm, Parr Lane.

11/00818/FUL Conversion of barn to dwelling at Billinge Hall Farm, Southport Road.

11/00829/FUL Demolish existing detached garage and erect a replacement garage with games room in the roof space at Avodate, Towngate.

Councillors had no comments relating to these applications.

139.11 Internal Audit
