The Chairman of the Open Spaces Committee described the procedure for the evaluation of tenders. The Committee has evaluated the tender documents from five contractors. Three of the contractors have been asked to clarify minor issues and, once the information has been received, the Committee will meet with a view to providing a recommendation for a contactor to the next Council meeting.

68.13 Football Pitch to the Rear of the Carrington Cente

Permission for the sub letting of the football pitch is awaited from the Landowner. The matter was deferred to a future meeting.

69.13 Eccleston Post Office

A consultation regarding the proposed move of the Post Office to new premises within the Carrington Centre redevelopment was considered. Councillors had no comments.

70.13 <u>Drapers Avenue Surface Water Drainange</u>

A report on a survey of the piped ditch between properties on Drapers Avenue and the Carrington Centre was provided. A camera survey has been completed and the ditch mapped. The results showed the pipe to be within the domestic curtilage of several of the properties and to be obstructed by tree roots. The Consultant has written to properties along the line of the drain advising of the findings and pointing out the riparian responsibility for drainage ditches.

Resolved: a response is to be provided to the resident who initially contacted the Council advising that the Council is unable to take the matter further.

71.13 Changing Rooms

Councillors considered a request from Leyland Moss Side Allotment Association, which includes a number of Eccleston residents, for use of the Meeting Room for bi-monthly meetings.
