### 01.23 Apologies for absence

Apologies were received from Councillors K Brown, M Brown, R Burns, M Frost and K-J Kelly.

### 04.23 Public Participation

A number of residents advised of concerns regarding a planning application at 148 The Green. The residents pointed out the application was not specific regarding the number of houses proposed, the submitted plans were inaccurate and the application was against Chorley Council policy for garden development. Concerns were also raised regarding drainage, flood risk, access from The Green, overlooking of neighbouring properties and impact on wildlife.

Resolved: an objection, on the grounds of the application being contrary to Policy HS3: Private Residential Garden Development, of the current Chorley Local Plan is to be submitted.

Chorley Council's Tree Officer is to be asked to look into the suitability of an historic Oak tree in the grounds of 148 The Green for a Preservation Order.
