The Clerk shall be allowed to spend up to £300 (+VAT) without prior approval of the Council

For expenditure of between £300 (+VAT) and £1000 (+VAT) the Chairman together with the Clerk shall have executive power

For the expenditure of between £1000 (+VAT) and £5000 (+VAT) prior approval of the Council shall be required

For expenditure of between £5000 (+VAT) and £25000 (+VAT) quotations from at least three firms shall be obtained

For expenditure exceeding £25000 (+VAT) the Clerk shall invite tenders from at least three firms.

61.21 Consultation - Nursery at Eccleston St Mary's CE Primary School

Councillors considered a consultation regarding establishing a Governor led nursery at the school. Prior to the meeting, details of a Governor Led Provision Pre-School, breakfast club and after school club at Eccleston Primary School had also been received.

Resolved: both schools are to be advised of the Parish Council's support for the proposals.
